The British Virgin Islands (the “BVI”) is one of the most popular domiciles for the formation of investment funds. The following comparison chart has been produced for the assistance of those who are considering the formation of an investment fund in the BVI. It compares the different requirements and key features of the regulated investment fund types available in the BVI.
